MC 117. TO APPROVE AS A TRUE AND ACCURATE RECORD THE MINUTES OF THE FINANCE & ADMINISTRATION COMMITTEE MEETING DATED 8th DECEMBER 2020.

MC 118. MATTERS ARISING:

There were no matters arising.

MC 119. TO APPROVE THE BUDGET OF THE COUNCIL FOR FINANCIAL YEAR 2021/22:

The Finance & Administration Committee of the Council had prepared and agreed the overall budget for the Council for the forthcoming financial year 2021/22, at its meeting of 8th December 2020, with a recommendation that this now go to Main Council for ratification and agreement

Councillors Mr & Mrs Harvey requested that the vote be a recorded one. This was agreed.

It was proposed by Councillor M Copeland, seconded by Councillor G Matthews and on a vote of 9 for with 2 against that the budget for financial year 2021/22, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The budget being agreed for financial year 2021/22 was as follows:

Expenditure £228,549.00

Income £56,079.00

Those voting against the budget: Councillor M Harvey and Mrs M Harvey.

MC 120. TO APPROVE AND SET THE PRECEPT FIGURE FOR FINANCIAL YEAR 2021/22:

The Finance & Administration Committee of the Council had after preparing and agreeing the overall budget for the Council for the forthcoming financial year 2021/22, at its meeting of 8th December 2020, agreed and set a precept figure with a recommendation that it be presented to Main Council for ratification and agreement.

It was proposed by Councillor G Hewlett, seconded by Councillor Mrs J Wild, and on a unanimous the precept figure for financial year 2021/22, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The precept figure was set at £115,020.00, which equated to an annual payment of £23.15 for an average Band D property (a decrease of £0.04p on financial year 2020/21).

MC 121. MATTERS OF URGENT PUBLIC IMPORTANCE:

(a) To discuss the Council's position on renewing its membership to the West Sussex Association of Local Councils (WSALC) in 2021: the Clerk introduced this item and reminded the Council of the current situation with regard to the review of SSALC being carried out by WSALC, and the possibility of WSALC breaking away from SSALC and becoming an independent and individual representative body for Parish and Town Councils in West Sussex. The Clerk reminded the meeting that this Parish Council had had no problem with the service that had been or were provided to them by SSALC and had already agreed that WSALC's actions were not supported.

It was proposed that the Council not renew its membership of WSALC on 1st April 2021 should WSALC become an independent body, away from the umbrella organisation of SSALC. And that this position be reviewed pending outcomes in the future, and particularly the outcome of the WSALC AGM to be held in February 2021.

There were no other matters of urgent public importance.

MC 122. BUSINESS AT THE CHAIRMAN'S DISCRETION:

(a) The issue of the current national lockdown and the higher risk of the "new virus" was raised. After discussion it was proposed by Councillor Mrs M Harvey, seconded by Councillor G Matthews, and on a vote of 10 for with 1 against agreed that until the end of the current lockdown Councillors

would receive all Council information and agendas etc by e-mail only. Council office staff were to be protected from unnecessary exposure to the virus and would therefore, until to the end of the current lockdown period, not deliver hard copies of agendas etc to Councillors and would work from home only. It was agreed, however, that a member of the parish office staff could enter the Community Hall building on one day in any week, only, to check on post, telephone messages and write cheques, and be in attendance for these tasks only.

It was agreed that this be reviewed at the end of the current lockdown period.

There was no other business at the Chairman's discretion.
