Councillor Glen Hewlett informed councillors that on 4th April 2025, the Secretary of State for Energy Security & Net Zero, Rt Hon Ed Miliband, awarded consent for the Rampion 2 Offshore Wind Farm. The Development Consent Order is for up to 90 wind turbines and foundations off the Sussex coast, subsea cables to bring the power to shore under Climping Beach, and an underground cable route to take the power to a new substation at Oakendene near Cowfold, before reaching final connection into the transmission network at Bolney, Mid Sussex.
