MC 68. TO CONSIDER NOMINATION OF AN ASSET OF COMMUNITY VALUE

County Councillor Jaine Wild outlined the request for a nomination of an Asset of Community Value which would incorporate the 27 acres of land that lie north and west of Downview Primary School in Felpham. Local groups use the land extensively as well as residents.

All paperwork had been submitted to councillors in advance of the meeting.

Councillor Russ Marsden-Sear proposed that Felpham Parish Council support the nomination of an Asset of Community Value for the 27 acres of land that lie north and west of Downview Primary School in Felpham. This was seconded by Councillor Glen Hewlett and unanimously agreed.

MC 69. COUNCILLOR ALLOWANCE DONATIONS

Councillor Russ Marsden-Sear advised that currently seven councillors do not take their allowances which, subject to Main Council approval, are then donated to local worthy causes. The request for this quarter's allowances are as follows:

Two allowances to Felpham Conservation Society to pay towards the VJ plaque in Old Rectory Gardens.

Two allowances to FAGS to assist with costs of increased security.

Two allowances to Felpham Belles for accessibility equipment.

One allowance to the Cat and Rabbit Rescue Centre

Councillor Glen Hewlett proposed that Felpham Parish Council accept the proposed donations. This was seconded by Councillor Bob Budd and unanimously agreed.

MC 70. GRASSMERE PARADE

Felpham Parish Council have held the license from West Sussex County Council to maintain the planting at Grassmere Parade since 1996. Our contractor visits the area twice monthly between February and October and once monthly between November and January. A heavy cut back is undertaken annually in September after bird nesting season finishes.

The bird nesting season in the UK typically runs from late March through August, spanning almost six months of the year when birds are actively building nests, laying eggs, incubating eggs, and raising young. This March to August window encompasses the core breeding activities for most common garden birds and woodland species across the country.

Under the Environmental Protection Act 1990, local councils and not Parish Councils are responsible for keeping public land clear of litter and refuse, including highways rubbish.

Representatives of the Post Office had previously been advised that Felpham Parish Council were responsible for the planting at Grassmere Parade and that councillors would consider any requests to prune the area but that these needed to be made to the relevant committee with appropriate plans. No request for an agenda item was made nor any plans received.

During bird nesting season, representatives of the Post Office, with no permissions in place and working with chainsaws in a public place with no health and safety risk assessments or appropriate measures having been taken, commenced severe hacking of the bushes. This included felling a 13ft palm tree.

Felpham Parish Council's contractor has visited site and expressed his dismay at the damage caused. A quotation has been given for remediation works to include digging out of the stump and replacing damaged bushes.

Councillor Glen Hewlett expressed his disappointment at the actions of the Post Office and the contents of the ill-advised letter that had been received on the matter from a resident.

Councillor Russ Marsden-Sear suggested an invitation be made to Post Office representatives to attend a meeting to discuss the matter. Councillors Glen Hewlett, Bob Budd and Russ Marsden-Sear are to be present at the meeting along with the Clerk.

Councillor Glen Hewlett proposed that an invitation be sent. This was seconded by Councillor Rick Parker and unanimously approved.

MC 71. TO DECLARE A VACANCY

In the event of a casual vacancy occurring, public notice must be given by the Parish Council, in accordance with Section 87(2) of the Local Government Act 1972. The notice must state the reason for the vacancy (i.e. resignation, death, failure to attend meetings for a period of six months, or disqualification).

Councillors resolved to declare a vacancy in the West Ward of Felpham Parish Council due to the resignation of Councillor Steve Baker.
