# MC 185. TO RECEIVE THE MINUTES OF THE MAIN COUNCIL MEETING HELD ON 5<sup>th</sup> DECEMBER 2017:

The minutes were **APPROVED** as a true and accurate record.

## MC 186. MATTERS ARISING:

**MC 163 (3)** – revised Members Register of Interests. The Clerk reminded Councillors that this document had been adopted by the Council at the last Main Council meeting. He advised that as of the date of this meeting he had only received back 5 completed forms and requested that those who had not filled in their forms to do so as soon as possible.

**MC 164 (ii) -** Councillor P English advised that the ADC Site 6 Advisory Committee would not be starting up again.

It was proposed by Councillor M Copeland seconded by Councillor G Matthews, and on a unanimous vote, that the budget for financial year 2018/19, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The budget for 2018/19 as agreed were as follows:

# MC 203. TO APPROVE AND SET THE PRECEPT FIGURE FOR FINANCIAL YEAR 2018/19:

The Finance & Administration Committee of the Council had after preparing and agreeing the overall budget for the Council for the forthcoming financial year 2018/19, at its meeting of 19th December 2017, agreed and set a precept figure with a recommendation that it be presented to Main Council for ratification and agreement.

It was proposed by Councillor P English seconded by Councillor G Matthews and on a unanimous vote that the precept figure for financial year 2018/19, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The precept figure was set at £106,330.00, which equated to an annual payment of £21.95 for an average Band D property (a decrease of £0.08p on financial year 2017/18).

It was recognised that in these austere times the Council had performed well in managing to stay within all of its budgetary targets.
