MINUTES OF THE MEETING OF FELPHAM PARISH COUNCIL HELD AT THE FELPHAM COMMUNITY HALL, FELPHAM 8th JANUARY 2019.

MC 181. APOLOGIES FOR ABSENCE:

Apologies had been received from Councillors Ms H Flynn, P English & Mrs R Kissell.

No other apologies had been received.

MC 182. ABSENCE WITHOUT APOLOGIES:

There were no absences without apology.

MC 183. DECLARATIONS OF INTEREST:

There were no declarations of interest at the outset of the meeting.

MC 184. PUBLIC QUESTION TIME:

There was 1 member of the public present. No questions or issues were raised.

MC 185. TO APPROVE AS A TRUE AND ACCURATE RECORD THE MINUTES OF THE MAIN COUNCIL MEETING HELD ON 4th DECEMBER 2018:

The minutes were **APPROVED** as a true and accurate record.

MC 186. MATTERS ARISING:

MC 165 – Scam Presentations – Councillor G Matthews now arranged for two further presentations along with one to be made at the Annual Parish (Electors) Meeting to be held in April 2019.

MC 167 District Green Infrastructure Masterplan – the Clerk confirmed that copies of the presentation made to this meeting had been received and circulated to all Councillors.

MC 167 Discharge into the Rife at Southern Water Depot – the Clerk, as requested, had contacted Karl Roberts of ADC on this matter, who had suggested the Council contact the Environment Agency (EA). This was done on the 11th December 2018 with an acknowledgement of receipt of the e-mail received from EA. A formal response was received on the 8th January 2019 stating that EA were unaware of any such incident and suggesting that this be

reported to their Incident Hotline (telephone) from which a report to investigate would be sent to their officers in the area. The Clerk now requested how the Council now wished to deal with this as he had no concrete/confirmed information on this and no dates or times to provide. It was agreed that Councillors keep an eye on the situation and should any sightings of lorries at the location be observed these be reported to the Clerk.

MC 171 – Councillor G Hewlett reported that the solar panels were due to be installed at the end of next week (17/18th January) and the acoustic curtains installed by the end of January.

MC 173 Matters Arising (A116 footpaths blocked off between Felpham, Bersted and Bognor Regis – the Clerk advised that, as requested, the forms against the closure of the access to the footpaths in question had been placed on the Council's web site.

There were no other matters arising.

MC 187. GENERAL CORRESPONDENCE/ANNOUNCEMENTS:

- 1) Arun District Council decisions made by Cabinet Members at ADC during December 2018 an on the 3rd and 10th January. None of the decisions had any direct effect on the Parish Council or residents of Felpham.
- 2) ADC the Council have been made aware that a review is due to be undertaken of Member's Allowance Scheme. The report from this will go to the Full Council of ADC in February 2019. The outcome of the review and decision will determine the level of remuneration for Felpham Parish Councillors post the next election.
- **3) WSCC** the Council are in receipt of the 2019/20 dates for JWAAC Meetings. These will be as follows: 6th February 2019 / 19th June 2019 / 27th November 2019 and 11th March 2020.
- **4) Age UK West Sussex –** the Council had received written confirmation that the grant made to the Regis Social Subscribing initiative would only be used for the patients from Flansham Park Health Centre.
- **5) Solafields** the meeting was advised of a consultation and exhibition event that was due to take place at the Felpham Memorial Village Hall on 14th January 2019 between 4 and 7.30 p.m. with regard to a proposed solar farm at Lidsey Farm.
- 6) ADC the Council were in receipt of proposed events to be held in Felpham during 2019 (these were only events that had been formally advised to ADC). Councillors were requested to note that these were all at the application stage and not to be promoted or advertised at this time. Copies of the events and proposed dates had been sent to all Councillors by e-mail.

NP 96 – Neighbourhood Plan Review – the meeting was requested to confirm/ratify the recommendation made by this Committee to Main Council, which was as follows:

"The meeting carefully considered the way forward on this. The Clerk and Neighbourhood Plan Advisor advised that the level of changes that had been made to the original NP document, with their only being minor amendments to existing policies (to make them more robust) and only a few additional new policies which were not significant to trigger any referendum in the future, that the meeting may wish to consider alternatives to the currently proposed public open consultations.

After much discussion the following was RESOLVED:

- 1) That the public open consultations to be carried out at two venues in the Parish not go ahead,
- 2) that the consultation process be carried out through Survey Monkey, and
- 3) to facilitate maximum input opportunities for residents to be involved and to comment on the reviewed document through Survey Monkey, the following mediums would be used to promote and advertise the survey:
 - Facebook
 - Twitter
 - Local newspapers
 - Parish Council web site
 - Felpham in Focus
 - Parish Council Noticeboards
 - Static displays x2 in different parts of the Parish.
- 4) It was further agreed that the public would also have the opportunity to comment and have input on issues outside of the NP that may be considered for inclusion in the existing Community Action Plan".

It was proposed by Councillor Mrs G Moss, seconded by Councillor Miss A Barker and on an unanimous vote RESOLVED that the recommendation made by the Neighbourhood Plan Committee (above) be agreed.

There were no other matters arising.

It was proposed by Councillor D Smart, seconded by Councillor M Copeland and on a unanimous vote, that the budget for financial year 2019/20, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The budget for 2019/20 as agreed were as follows:

Expenditure £245,721.00

Income £65,500.00

MC 201. TO APPROVE AND SET THE PRECEPT FIGURE FOR FINANCIAL YEAR 2019/20:

The Finance & Administration Committee of the Council had after preparing and agreeing the overall budget for the Council for the forthcoming financial year 2019/20, at its meeting of 18th December 2018, agreed and set a precept figure with a recommendation that it be presented to Main Council for ratification and agreement.

It was proposed by Councillor M Copeland, seconded by Councillor G Hewlett and on a vote of 9 for, 0 against and 2 abstentions (Councillors Mr & Mrs Harvey) that the precept figure for financial year 2019/20, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The precept figure was set at £111,471.00, which equated to an annual payment of £22.62 for an average Band D property (an increase of £0.67p on financial year 2018/19).

MC 201. MATTERS OF URGENT PUBLIC IMPORTANCE:

There were no matters of urgent public importance.

MC 202. BUSINESS AT THE CHAIRMAN'S DISCRETION:
