As there was no Seconder to Councillor M Harvey's paper the proposal fell and this item was therefore discussed no further.

PR 68. PUBLIC ACCESS DEFIBRILLATOR:

Councillor Mrs G Moss proposed that a training defibrillator be purchased to use at Resilience and annual events etc. and so that Councillors can be trained how to operate an AED with confidence. This was seconded by Councillor Miss A Barker and on a vote of 7 for with 1 abstain – as the item was under £500 – the request of the purchase of this would go to Main Council on 3rd September.

It was noted that a possible defibrillator was to be purchased by the Methodist Church in Felpham. Admin Assistant to the Clerk to contact Reverend Dan Balsdon regarding this.

PR 69. RESILIENCE:

Successful Resilience Awareness Training had taken place, Councillor M Rumsey had trained on Radio Communication and we now have a Critical Incident Debriefer on board – Pepe Braziliton.
