December was as usual a quiet month with the purdah for the General Election in force until 12th December and the Christmas holiday period from 23rd December. Issues with parking on and near junctions continue to cause mayhem for residents, pedestrians and road users. Perhaps I could have a better chance of making changes if we mapped the offending areas in the whole of Felpham to show the extent of the problem. Volunteers welcome to help me!

The fatal accident at the Felpham Way lights junction was a tragedy – I have a report from WSCC but it is sub-judices whilst police investigations continue. However, I have highlighted the problems incurred whilst the B2259 was shut (6 hours) and traffic diverted through the village. I watched in amazement as one car drove through the police road block (she was chased and pulled over). The further accident at Snooks Corner was probably resulting from the agitation of motorists taking so long to get through. I will forward any report in due course.

At WSCC, I have been appointed to the Corporate Parenting Panel, whose main role is to oversee the welfare of 'look after children' in the county. Following the critical Ofsted report of Children's Services this panel has been overhauled and charged with implementing government recommendations for improvements. I have, therefore, decided to stand down from Adult Services.

MC 179. TO APPROVE AND SET THE PRECEPT FIGURE FOR FINANCIAL YEAR 2020/21:

The Finance & Administration Committee of the Council had after preparing and agreeing the overall budget for the Council for the forthcoming financial year 2020/21, at its meeting of 10th December 2019, agreed and set a precept figure with a recommendation that it be presented to Main Council for ratification and agreement.

It was proposed by Councillor G Hewlett, seconded by Councillor G Matthews and on a vote of 9 for, 3 against (Mr & Mrs Harvey and M Rumsey) that the precept figure for financial year 2020/21, presented to this meeting by the Finance & Administration Committee, be approved and agreed without amendment. The precept figure was set at £113,181.00, which equated to an annual payment of £23.19 for an average Band D property (an increase of £0.57p on financial year 2018/19).
