MINUTES OF THE MEETING OF THE MAIN COUNCIL OF FELPHAM PARISH COUNCIL 4th FEBRUARY 2020.

In the absence of the Chairman, the Vice-Chairman of the Council, Councillor Mrs G Moss chaired this meeting.

MC 184. APOLOGIES FOR ABSENCE:

Apologies had been received from Councillors Mrs J Wild & D Smart (unwell).

MC 185. ABSENCE WITHOUT APOLOGIES:

There were no absences without apology.

MC 186. DECLARATIONS OF INTEREST:

There were no declarations of interest at the outset of the meeting.

MC 187. PUBLIC QUESTION TIME:

There were no members of the public present, therefore no questions or issues were raised.

MC 188. TO APPROVE AS A TRUE AND ACCURATE RECORD THE MINUTES OF THE MAIN COUNCIL MEETING HELD ON 7th JANUARY 2020:

The minutes were **APPROVED** as a true and accurate record.

MC 189. MATTERS ARISING:

There were no matters arising.

MC 190. GENERAL CORRESPONDENCE/ANNOUNCEMENTS:

1) Correspondence Received:

- Decisions made by Cabinet Members at ADC during January 2020. The decision was made by the Cabinet Member Councillor Stanley, that the following would be continued by ADC:
 - (i) Administer the reviews of the Public Space Protection Order (PSPO) containing dog controls,
 - (ii) Deliver enforcement of the PSPO dog controls (including dog fouling) via contracted enforcement officers.
 - (iii)contract stray dog collection, kennelling, return and where necessary rehoming services, and enforcement of micro-chipping requirements in respect of stray dogs.

ADC will delete the vacant Dog Warden post and formally cease to provide the following discretionary services – dog behaviour interventions, other fouling interventions, dog welfare complaints, updating dog signage, educational work including provision of public information and attendance at dog shows and similar.

No other decisions made had an impact on the Parish Council or residents of Felpham.

- 2) WSCC information on consultation on WSCC Permit Scheme (consultation closes on 21st February 2020). All Councillors had received a copy of this prior to the meeting.
- 3) Environment Agency notification of maintenance work to be carried out on the EA building at the far south west corner of the parish along with a stretch of defences/channels in the same area.
- **4) ADC** notification of a meeting to be held on the 7th February 2020 with regard to an update on CiL (which comes into effect on the 1st April 2020).

MC 191. REPORTS FROM COUNTY/DISTRICT COUNCIL MEMBERS:

All County and District Councillors for Felpham had been invited to attend the meeting and provide a report/update from their respective authorities.

(i) County Councillor Ms H Flynn – reported the following:

"Starting with good news, I attended the formal opening of Felpham Community College extension as did your Chairman. It is a fantastic addition, well designed and giving new facilities for the art, music, drama, IT and more. It is possible that FCC will also be offering places for children with special educational needs in 2021. Consultation is underway for Felpham and other schools in the county to ensure that where possible all children are included in mainstream education. www.westsussex.gov.uk/sscphase2 to give your comments.

I understand that some residents on Roundle Estate are concerned with proposals to close some roads to through traffic. I have contacted WSCC who gave me the following statement:

The proposers of this scheme (the resident groups) have consulted with the emergency services, who have not raised any concerns. The county council did not raise any concerns, due to the opening of the relief road and therefore a very suitable alternative route is available should the B2259 be closed. Firs Avenue is not being affected and therefore the vehicles are still able to bypass the traffic lights at Downview Road. It is the proposers responsibility (and is clearly in their interest) to ensure that what they are planning does not adversely impact the residents, not the county council's. WSCC is simply a consultee in the same way that we would be in a planning application.

I have spoken with the Highways Planning Officer regarding the complaints about the Community Hall signage. I am was not content with the letter sent to the parish who had, to my mind, managed the signage with due regard to guidelines. He is passing this on to Ben Whiffin as I have asked for a sensible conclusion to this matter.

Next week is the meeting which will debate and decide the WSCC council tax for the coming year. I expect it to result in an increase of less than 4%. Not good news but increased funding must be found to improve children's services and fire/rescue services".

- (ii) District Councillor Paul English (Felpham East) the issue of two and three weekly bin collections, by ADC, and new bins for food wastage would be out for consultation, at some time in the future. It was also confirmed that the change from Cabinet to Committee system at ADC, would be going forward.
- (iii) District Councillor Mrs Gill Madeley (Felpham West) had sent her apologies and had advised that she had nothing new to report.
- (iv) District Councillor Mrs Elaine Stainton (Felpham West) was absent from the meeting and no report had been received.
- (v) District & County Councillor David Edwards (Felpham East) was absent from the meeting and no report had been received.

MC 192. DATES OF OUTSIDE BODIES MEETINGS & REPORTS FROM MEMBERS ON OUTSIDE BODIES:

PL 126 Neighbourhood Plan – the Clerk confirmed that the Regulation 14 consultation process had started on the 20th January 2020 and would finish on the 2nd March 2020.
